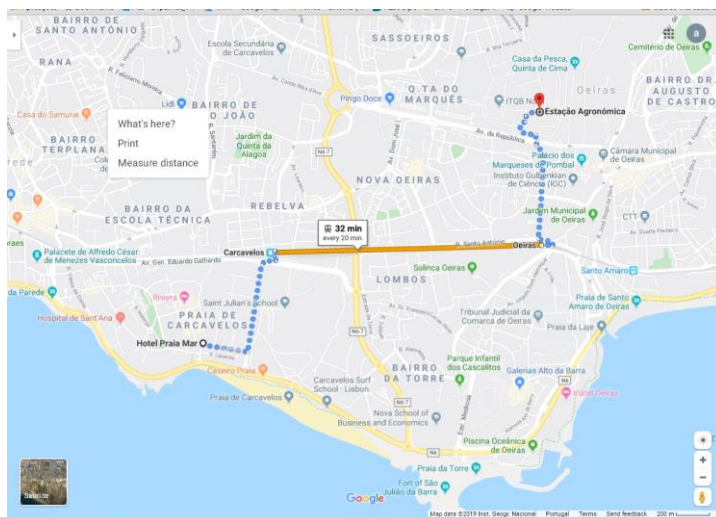
Option 1- near Oeiras

Train : Linha de Cascais, direction Cascais towards Lisbon, the rest of the route walking.



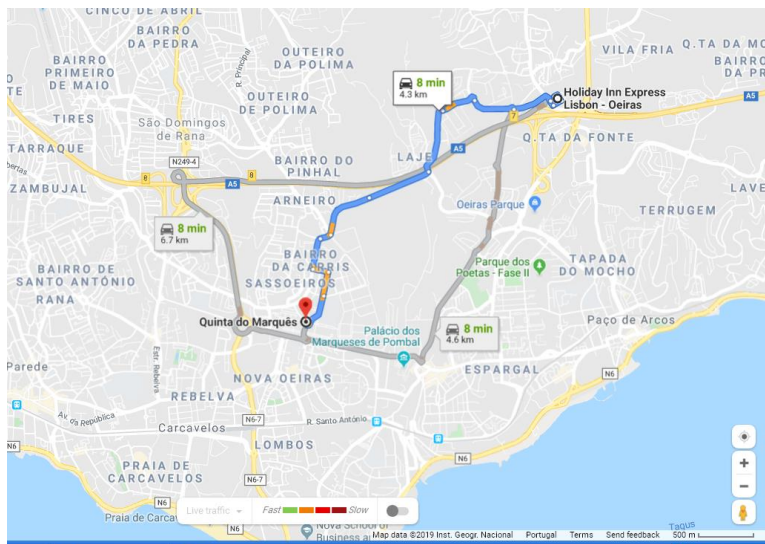
Option 2 – near Oeiras
